Presidential Scholar	\$64,000	\$16,000	\$8,000	(Top 10% at an Accredited High School or 3.80 GPA) AND (ACT 29 or SAT 1350) OR (CLT 91)
Dean's Scholar	\$60,000	\$15,000	\$7,500	(Top 25% at an Accredited High School or 3.40 GPA) AND (ACT 24 or SAT 1160) OR (CLT 76)
Yellow Jacket Scholar	\$56,000	\$14,000	\$7,000	(Top 50% at an Accredited High School or 2.50 GPA) AND (ACT 19 or SAT 990) OR (CLT 64)
Academic Incentive Grant	\$28,000	\$7,000	\$3,500	This is awarded to students who demonstrate strong academic promise. Those who receive this grant may move up to the Yellow Jacket Scholarship level following their second consecutive semester. This move in scholarship level is based upon the successful completion of the Provisional Program, as certified by the Collegium. Such increase in a scholarship award may require adjustment of the total aid.

Students graduating from a Home School will be evaluated for scholarships based on high school GPA and test scores and the county of residence at the time of graduation.

Presidential Transfer Scholar	\$16,000	\$8,000	3.80 Cumulative GPA based upon transferable credit from a regionally accredited institution or membership in the Phi Theta Kappa honor society; Presidential Transfer Scholars are eligible to apply for the Honors Academy Scholar award – see Honors Academy section for first-year students
Dean's Transfer Scholar	\$15,000	\$7,500	3.40 Cumulative GPA based upon transferable credit from a regionally accredited institution; Dean's Transfer Scholars are eligible to apply for the Honors Academy Scholar award – see Honors Academy section for first-year students
Yellow Jacket Transfer Scholar	\$14,000	\$7,000	2.00 Cumulative GPA based upon transferable credit from a regionally accredited institution
Transfer Academic Incentive Grant	\$7,000	\$3,500	Awarded to students who demonstrate strong academic promise

Legacy Scholarship	\$15,000	\$7,500	Awarded to first-time transfer students whose parent or grandparent graduated from Howard Payne University

Transfer scholarships are awarded to students who have completed a minimum of 12 transferrable credit hours following high school graduation. Official college transcripts are required to substantiate the cumulative GPA and the number of transferrable credit hours.

Students who graduated from a Home School will be evaluated for scholarships based on the county of residence at the time of high school graduation.

Scholarship	Semester Award	Eligibility Criteria
Baptist Ministerial Dependent Scholarship	\$750	An application must be obtained from and approved by the dean of the School of Christian Studies (325-649-8403) prior to the first semester's registration period. Renewal review occurs annually.
Baptist Ministerial Scholarship	\$750	An application must be obtained from and approved by the dean of the School of Christian Studies (325-649-8403) prior to the first semester's registration period. Renewal review occurs annually.
HPU Sibling Grant	\$500	Full-time students at HPU who have one or more siblings also enrolled at HPU full-time will qualify for \$500/semester. Siblings must be from the same household. Awards are considered on a semester-by-semester basis.
